MEETING MINUTES:

Carsten's Lake Project, Jim Kettler, LNRP

- Jerry Corfman pointed out that this project is different than the Elkhart Lake project.
- LNRP is looking for \$5,000 to help fund the 2 year analysis costs.
- The project is all about harvesting phosphorus
- Intent is to drive up to the slag filtration area to check or change slag bags.
- The end product could possibly be used for fertilizer or on road beds.
- Slag does not release the phosphorus once attached.
- Wisconsin Department of Natural Resources has done an eco-toxicity tests and approved the process.
- Each bag may weigh 30 – 40 dry weight pounds. They can be any weight for better handling.
- Research will give mathematically the absorption capacity.
- Additional testing is going to be done on Pine Creek to study flow and phosphorus.
- Slag is provided free because it is a byproduct.
- Land owner may have area to store slag or future use.
- The filtration area would hold 8 to 10 slag bags in multiple filtration structures.
- Maintenance would involve filling slag bags and checking the filtration structures.
- This pilot program could ultimately help many lakes throughout the state.
- All of Carstens Lake resident are to get invited to the 6/30/22 general membership meeting. The meeting is hopefully going to be held close to the lake.
- Over all grant for the project is \$250,000
- Additional \$32,060 for 2 year research and analysis and grad students. LNRP is contributing \$5,000. UW Stevens Point is contributing \$22,060. Leave MCLA to contribute \$5,000 from the grant account.
- The \$32,060 will not be an ongoing cost after the 2 year research and analysis period.

Carsten's Lake Project, continued

- Suggestion was made by Dave Pozorski that MCLA write for a grant to cover the \$5,000. They can ask The John and Ruth West Foundation and Manitowoc County Fish and Game. Jim Kettler offered help with writing the grant request.
- Carstens Lake Association meeting is 6/11/22.
- Motion was made by Dave Pozorski and seconded by Scott Umland that without a major objection from the Carstens Lake Association that MCLA obligates \$5,000 towards the 2 year Carstens Lake Pilot Project. Payable to LNRP as the fiscal agent and holder of the DNR Lake Management Grant. The motion passed unanimously.

- General account = \$7,259.16
- Grant account = \$19,781.15

Upcoming Meeting:

- Will hopefully be on 6/30/22 at 6:30 pm.
- Possibly at Newton Town Hall. Carstens Lake representatives will look into the possibilities.
- Discussions will likely concentrate on the Carstens Lake Pilot Project.
