MEETING MINUTES:

Called to order by Jerry Corfman, President Introduction of guest speaker, Jason Breeggemann and Mel Mohr, DNR Fisheries.

Program by Jason Breeggemann and Mel Mohr, DNR Fisheries

- Jason has 20 years in fish biology at multiple locations.
- Lake surveys use fyke nets close to ice out. Mainly for walleye and northern.
- Lake surveys use electro fishing in May when water temperatures are between 60 and 70 degrees. Mainly for bass and pan fish.
- Net nights and electro fish miles are used.
- Pertinent information is collected on fish.
- Fish scales have rings and fish age can be determined by rings.
- All information is analyzed to make fish management decisions.
- Goal is to have a balance fish population. Large and small fish.
- Silver Lake is undergoing fyke nets and electro fishing in 2023.
- Rockville flowage is undergoing electro fishing in 2023.
- 8" to 10" of Rainbow trout have been stocked in Horseshoe lake.
- Experimental pan fish regulations are in effect until 2026

Cedar Lake comprehensive fish survey

- 20 net nights, 686 fish, 12 species.
- 2½ miles of electro fishing includes 1 mile dip all fish and 1½ miles dip game fish only.
- 189 fish and 8 species collected.
- Good pike population with size mostly 16" to 23".
- Pike growth rate lower than average for males and females.
- Crappie had a moderate catch rate. Average size crappie was 8.3".
- Crappie growth rate was slightly less than state average.
- Bass had a good electro fishing catch rate.
- Bass had good size structure.
- Bass growth rate was very close to state average.
- Bluegill had moderate electro fishing density rage.
- Bluegill growth rate were a little lower than state average.
- Fyke net produced 6 walleye, all over 23". (continued)

Cedar Lake comprehensive fish survey (continued from page 1)

- Last walleye stocking was in 2018.
- Possible recommended regulation change for northern pike would be to have a 25" to 35" protected slot size and harvest of 2 outside of the slot size.
- Possible recommended regulation change for pan fish would be a reduced bag limit. Possible 15 total, 5 anyone species.
- No change for bass regulations.

Long Lake comprehensive survey

- 15 net nights, 1454 fish, 15 species.
- 2½ miles of electro fishing includes 1 mile dip all fish and 1½ miles dip game fish only.
- 295 fish and 11 species caught electro fishing.
- Northern pike had high catch rate and good help.
- Northern pike average size was 26" and largest fish was 35".
- There is a good population of legal northern pike.
- Northern pike growth rate is above the state average for male and female fish.
- Walleyes had moderate catch density.
- Walleyes had good size.
- Crappies had very abundant catch rate.
- Crappies had decent size structure. With average being 7½" to 9½".
- Crappies growth rate was good but slows after 4 years.
- Bass had good catch rate and healthy population.
- Average size bass was 13.9" with the largest being 19%".
- Bass growth rate is similar to state average.
- Bluegill had moderate to high catch rate.
- Average size bluegill was 6".
- Bluegill growth rate is better than statewide average.
- No regulation recommendation changes.

Update Carsten's Lake project: Jim Kettler-LNRP, Sarah Majerus-Stantec, Aaron Volkening-Stantec, Jesse Haen-NRCS

- Per Jim Kettler, total grants for the project are approximately \$450,000.
- Per Jesse Haen, there will be a sediment scrape to increase retention time and increase watershed capacity.
- Per Jesse Haen, this will be good for habitat and for animals.
- Per Aaron Volkening, design is updated, scrapes are east of pine creek, basin west of pine creek. Diverting high water events of pine creek into basin. Outlet structure hopes to have slag filters to capture phosphorous. Still working on how slag will be held. Ordinary high water work has been established. This is good for permitting and how to catch more water.
- Project is hoping to reduce 20% of phosphorous from coming in. This could be improved if more water can be treated. Hoping slag will help improve also. This project, if successful, will hopefully help other lakes in the future.
- Six interns are being hired to collect samples on pine creek this summer. They will test for E. coli phosphorous and other items.
