### MEETING MINUTES:

### Introduction of Jason Breeggemann

- Fisheries Biologist for Manitowoc County, Brown County and Muskellunge and Walleye in the Bay of Green Bay,
- Jason has worked in varies different states and projects though out the United States. Most recently in Shawano County.
- In 2022 Jason has been active with fish surveys that include, fyke netting on Cedar Lake and Long Lake. He hopes to follow this up with electrofishing on the same lakes.
- Horseshoe Lake is stocked with trout by the Department of Natural Resources. Creel Cards have been put at the boat landing for anglers to complete.
- The suggested regulation changes implementation has been started for Wilke Lake. This will affect the bass, walleye and northern size and possession limits. It is a lengthy process and the earliest final implementation would be in 2024.
- Discussed that there has been an ongoing 5 year and 10 year panfish study. Different limits were changed on several lakes throughout the state. The results are not complete.
- Jason would entertain volunteers for habitat improvement projects.

### Presentation by Jerry Halverson, Department Director, Manitowoc County Soil and Water.

### Gass Lake

- Project was to build a diversion from a 400 plus acre watershed that was running into the lake. This is to improve the phosphorus levels in the lake.
- The lake was the 3rd worse in the county for phosphorus.
- The planning and permits took many hours and years.
- August 2020 an excavator was hired.
- A pass and clay dike was constructed to divert the water. The pass is 2' deep and 7' wide.
- The cost of the project was approximately \$8,500 and was funded by private parties and the Gass Lake Association.

### **English Lake:**

- Drain tile and erosion was running into the lake from a neighboring property.
- The lake management plan had to be updated and passed.
- A grant was applied for but was not received. The project was ultimately paid for by other grant moneys.
- On 4/19/2022 a drain tile was diverted away from running into the lake.
- On 4/27/2022 an additional drain tile was diverted away from running into the lake.
- The water now running into the lake will be substantially cleaner.
- The cost of the project was approximately \$33,000.
- Presentation by Sarah Majerus, Stantec & Jim Kettler, Lakeshore Natural Resource Partnership.

### **Carstens Lake Water Quality Improvement Project – Progress Report:**

- Project is to help harvest the phosphorus before it enters the lake.
- A grad student is hired to complete a 2 year study on the slag and phosphorus.
- The designed was changed from the original to a neighboring upland area.
- The design is to pick up the water flow from Pine Creek and treat it with slag filtration system before the water enters the lake. Phosphorus binds to slag.
- It is anticipated that the slag filtration bags would have to be changed annually. The bags are to be easy to access and handle.
- If the slag filtration system is ever removed it would leave the area with an enhanced wetland and sedimentation area.
- There is a 2 year research grant for the management plan and implementation plan.
- NRCS cost share moneys are available for the project.

- The meeting minutes from the 9/24/2021 general membership meeting are on line and Scott had copies for review.

Proposed bass regulation to 18" size limit with a daily bag limit of 1.

Proposed walleye regulation to 18" size limit with a daily bag limit of 3.

Proposed northern regulation to a 25" – 30" protected slot limit with a daily bag limit of 2.

### **Manitowoc County Fish and Game:**

- 3 new handicap accessible piers are being installed.
- They are at English Lake, Pigeon Lake and Wilke Lake.
- The piers are floating so they should not have to be removed.
- The average cost of the piers is \$25,000.
- Piers were paid for by Manitowoc County Fish and Game. THANK YOU!
- Voluntary boat landing donation tubes throughout the county have collected the following:
  - 2019 \$12,469
  - 2020 \$22,331
  - 2021 \$18,000
