- The Wisconsin Lakes Partnership and the Lake Leadership Institute is around 50 years old.
- Designed to partner to help lakes with education programs.
- They are funded by the fees paid by motorboat owners.
- There are around 6 ½ million in grants.
- They have a newsletter called Lake Tides.
- They have a Leadership Development Program. It is designed to help people take care of their lakes. The Lake Leadership Program consists of 3 seminars. 1st is Society and Environment commonly held at Big Green Lake. 2nd is Aquatic Ecology and Watershed Management commonly held at Lake Tomahawk. 3rd is Organization, people and politics commonly held at the Aldo Leopold property in Sauk County.
- Nominations are available for Crew 15, 2024.
- There are 25 30 people per crew and commonly there are more nominations than space available.
